RE: RESPONSE TO PROPOSED CURRICULUM CHANGE:

The following information is provided in response to your Library consultation request: This response addresses the proposed curriculum changes and covers all of the proposed changes to existing courses, Public Organization (POL AMER 5153), Quantitative Methods for Politics and Policy (PUBPOL 6275), Topics in Public Policy (POL AMER 4176/5176), Internship in Public Policy (PUBPOL 6281), Public Budgeting (POL AMER 3172); the new course proposals, including Politics and Public Policy (PUB POL 6201), Program Evaluation (PUB POL 6204), Research in Public Policy (PUB POL 6301); and the new Major/Minor/Emphasis proposal—Graduate Certificate in Public Administration.

Rod Library resources should be adequate to support the proposed Master's in Public Policy (MPP) curriculum. Our collection is fairly strong overall in terms of specific materials related to the topics covered in the MPP program. There is access to an abundance of scholarly, peer-reviewed articles, chapters, and ebooks published within the last ten years that support the proposed curriculum. Graduate students enrolled in the MPP program can access these materials online through OneSearch!, individual databases, and UNISTAR, Rod Library's online catalog. Access is available to enrolled students from off campus. Graduate students can also submit InterLibrary Loan requests online for books, articles, and other material that Rod Library does not own.

As the MPP program evolves in its new format, it is important to communicate with the library and Continuing Education continuously regarding the Political Science faculty's need for library materials. Since the program will be online for the most part, there are special factors that come into consideration for library materials. These factors include:

• Rod Library has e-books available through subscription and acquisition models through the ProQuest ebrary database. Single-user titles are not available for download. Multi-user titles are available for download. Students in the MPP program should be able to access these e-books from off campus using their CatID and password. If any issues arise with a student or faculty member trying to access and/or download a title through ProQuest ebrary, please notify the library as soon as possible.

Video streaming licenses must be obtained to show any video to an online course.

Obtaining streaming licenses is often very complex, time-consuming, and expensive. Please

contact Continuing Education as far in advance as possible.

It is extremely important to note that the Library's recurring materials budget has been static for several years. This situation, coupled with inflation in materials costs, severely limits the Library's ability to acquire new resources in any format and could make it necessary for the Library to reduce its current subscriptions to electronic resources (databases, e-journals, etc.).

If any problems arise related to accessing library materials online, please ensure that Rod Library is contacted about these problems so they can be resolved quickly.

Based on the Library's review of your proposed curriculum change and subsequent analysis of the anticipated impact on Library services and resources:
