## Alternative fix for .ids-Writing bundle

Hello, after consulting with colleagues involved in the .ids-Writing bundle, I believe we have a workaround that keeps the bundle at 15 credits while dealing with the issue of hidden prereqs and maintaining the curricular integrity of the program. There are some housekeeping details that are necessary to note/follow up on for this to work, which follow (deletions in crossout; additions in bold):

 English 4785 current prereqs: ENGLISH 2770 (620:077) and one of the following: INSTTECH 4170/5170 (240:170g) or ART 3030 (600:125) or ENGLISH 4765/5765 (620:102g) or ENGLISH 4770/5770 (620:104g) or ENGLISH 4775/5775 (620:105g) or ENGLISH 4780/5780 (620:107g) or consent of instructor; junior standing. (Variable)

Prerequisite or corequisite: ENGLISH 2770 (620:077) or consent of instructor; junior standing. (Variable)

- English 4785 proposal:
- In the 2018-19 curriculum cycle (so, going into effect this summer), a change was made to the prereqs for English 4025 and 4040, eliminating any hidden prereq:
  - English 4025 & 4040 current prereqs: Prerequisite(s): LAC Category 1A or its equivalent; junior standing. (Variable) [4040 also has "consent of instructor"]
  - English 4025 & 4040 in-process change: Recommended prerequisite(s): LAC Category 1A or its equivalent or consent of instructor
- In upping the number of required courses, it will be more important than ever for us to be able to track how many and who the IDS-Writing bundle students are. Has the Registrar's Office agreed to the necessary major code changes?
- If there are students currently in the pipeline who are taking Advanced Writing courses without having taken 2770, they would, of course, be grandfathered in by the old requirements and allowed to continue enrolling for courses via instructor permission.
- Finally, while it is absolutely appropriate and necessary for the UCC and Senate to search for hidden prereqs and to ask for changes, it is poor management practice to do so outside of the conventional curriculum process. Insisting that programs that have run successfully for almost a decade make changes immediately and in the midst of finals week results in exactly the kind of seat-of-the-pants curriculum that has to be revised on the fly and runs the risk of not being fully thought through. I hope the UCC and Senate will make efforts to respect its own procedures in the future. They are thoughtful procedures which, though not speedy, work well.

Diane,

Following is a message I received from Jim O'Loughlin, Associate Department Head in Languages & Literatures, regarding a solution for the curricular problem tabled in the senate, related to the Interactive Digital Studies (IDS) programs (major and minor), specifically to the Digital Writing emphasis. A summary of the solution is that the department wishes to eliminate the second prerequisite for all students, including IDS students, leaving only ENGL 2770 as a prerequisite for ENGL 4785. They have a separate curricular change already approved that makes ENGL 2770 a corequisite, instead of prerequisite for ENGL 4785. Then, because required courses are now 9 credits, including the previously hidden corequisite ENGL 2770, they would also like to change the program to require only 6 elective credits, instead of 9, to preserve the program's original requirement of 15 credits for completion.

Please do contact me and/or Jim O'Loughlin if you have any remaining questions or concerns. Although the Senate still needs to ratify the proposal on January 13, I am quite confident they will do so, given the robust participation of affected faculty. All of the faculty involved in resolving this situation have very much appreciated your flexibility, your patience, and your guidance. Thank you!
