Comments from President Nook [time stamp 00:00:40]

Announced a \$25M gift and potential renaming of the College of Business, pending BOR approval. The BOR meeting in mid-November will also deliver the BOR's recommendations from the DEI study report. Last BOR meeting approved our appropriations requests.

Provost Herrera gave a brief update on the current admissions cycle applications.

Over 300 responses to the survey on proposed new titles; responses were generally favorable with some concerns voiced by respondents as well.

Comments from NISG President Krutsinger [time stamp 00:07:18]

NISG met with BOR to request an additional \$1 million from the state, working with BOR to get that passed by the state legislature. The NISG Board of Directors mainly filled; only a few senate seats open.

1569 College of Business and Interdisciplinary Curriculum Proposals [time stamp 00:09:37]

Chad Heinzel spoke briefly and noted this was a pretty straightforward package that moved through quite smoothly.

1574 College of Education Curriculum Proposals [time stamp 00:12:12]

MOTION: Balong / Gould (22 in favor, 0 against, 1 abstention)

Chad Heinzel spoke briefly; noted this was also smooth; highlighted the Panther Pathway as a new pathbreaking proposal which passed after some discussion.

Consultations:

1570 Consultation: Campus Climate Study [time stamp 00:13:44]

Update by Cara Burnidge & Kristin Moser. Project began in Jan. 2022 and is in final stages. Full results are available online. Climate study team conducted Faculty Forums to hear feedback on the results and is reviewing findings from forums and drafting recommendations this semester for actions. Climate Study Work Group is waiting to hear what BOR guidance will be with respect to DEI, which may impact recommendations.

Chair Dobosh noted this was a simple change to publicize policy changes via campus-wide email instead of the InsideUNI newsletter.

1573 Revisit Docket #1519: New Process for Curriculum Proposal [time stamp 00:25:00]

MOTION: Elgersma / Stollenwerk

Senator Stollenwerk presented a petition to include College Senates in the curriculum review process to ensure that curriculum receives thorough review from those most qualified to review and understand the content of each course. Senator Stollenwerk noted that curriculum is the Faculty's most important and primary responsibility and argued that we need to ensure we uphold that responsibility through thorough review, either by College Senates or by Faculty Senate itself.

Robust discussion ensued, with themes including the ability of College Senates to voluntarily add that layer of review themselves, the difficulty in doing so given the timeline and faculty workload, problems working with the LEEPFROG system, the high frequency of errors found by College Senates and the UCC, operation of the UCC as a faculty body with the administrative support of the Associate Provost, the need

to assess the operation of the new curriculum process before going back to the previous system, the advantages of a faster cycle in responding to a competitive and changing educational landscape, the weakness of relying on College Senates when conflicts might often arise from outside of the college, the advantage of having a university-wide summative spreadsheet of all curriculum changes published and possibility of having a "working version" of this earlier, and the need to balance a timely and thorough review process. Discussion converged on a need for Faculty Senate to establish an ad hoc committee to assess the efficacy of this first curriculum cycle under the new system and make recommendations on potential improvements. Senator Stollenwerk withdrew his petition in favor of creating such a committee.

Motion was made to form ad hoc subcommittee to review all aspects of curriculum process, including all aspects of the operation of the UCC [time stamp 01:28:25].
