### **University Faculty Senate Minutes**

January 25, 2021

### Call to Order at 3:30 PM [time stamp 0:00:00]

Following a precedent set in earlier meetings to maintain order in the Zoom virtual environment, all microphones were closed at the beginning of the meeting and participants opened them to speak only if recognized by the Chair. In past Zoom senate meetings, senators used yes and no buttons to vote accordingly, and selected neither button to abstain from voting. However, recent changes to the Zoom software prevented some Senators from using these features, so we used the raised-hand feature to enable voting during this meeting.

#### **Courtesy Announcements**

Comments from President Nook [time stamp 0:00:40]

President Nook announced the departure of Provost Jim Wohlpart, who is assuming the Presidency of Central Washington University. He described detailed plans for a search to replace the Provost, including the composition of a search committee. He named Amy Petersen, Chair of the Faculty, as Co-Chair of the search committee, with an announcement regarding the other Co-Chair to follow.

### Comments from Provost Wohlpart [time stamp 0:07:48]

University leadership is tracking a number of bills in the legislature currently, including the tenure bill, and have reached out to many community leaders to help stop this initiative. Budget-related matters and the status of higher education faculty in the public health priority for the COVID vaccine are other matters included in this effort. Provost Wohlpart also suggested that faculty watch closely for messages about upcoming weather-related cancellations, due to the impending storm.

### Comments from Faculty Chair Petersen [time stamp 0:11:15]

Reiterated desire to have a broad representation of faculty on the Provost search committee, and suggested that interested faculty respond to President Nook's upcoming call for search committee members. Then, she reminded faculty of recent changes to Policy 3.06, specifying that students must complete the Panther Health Survey to inform faculty and the campus of their need for COVID-related accommodations.

Comments from United Faculty President Hawbaker [time stamp 0:13:46]

President Hawbaker thanked Provost Wohlpart for his collaborative partnership with the faculty over the last several

years, and wished him well in his new role. She also provided an update regarding the current bargaining negotiations, referring to her recent letter to the faculty. She encouraged faculty to participate in the upcoming listening session, announced in the letter. She asked that we encourage faculty who have received an evaluation letter they perceive is unfair to contact United Faculty for help.

## Comments from NISG President Boeding [time stamp 0:17:48]

NISG is also watching the legislative environment closely, and would like faculty to encourage students to contact NISG if they'd like to learn how to voice their concerns with legislators, and if they'd like to accompany NISG officers and representatives to the State Capitol at significant moments throughout this year's session. Reminded us that student elections begin February 8, and asked us to encourage students to participate in these elections, including encourage some to run for leadership offices.

Comments from Senate Chair Burnight [time stamp 0:21:50]

Encouraged senators to volunteer to participate in University committees, and announced that he would soon provide senators with a list of this year's open seats.

### **1411** Consultation: Fall 2021 Academic Calendar [timestamp 0:49:45]

Associate Provost Patrick Pease presented multiple calendar modifications for next year, given what we have learned from our experience with altered calendar arrangements due to COVID-related challenges. Variables included especially: inclusion of a Winter term, 15-week and 16-week terms, beginning and ending dates of semesters and academic years, and the timing of Fall and/or Thanksgiving break. Discussion ensued, and some points of consensus were apparent.

### 1412 Proposed change to Policy 3.06 regarding religious observance [timestamp 1:13:37]

Much discussion ensued, especially regarding the need to more clearly define what does and doesn't count as religious observance. Senator Degnin moved to table the item for the next meeting, due to time constraints, with second motion by Senator Hesse. The vote to table passed (13-0-4).
