### **Comments from President Nook**

00:00:46 – 00:08:41

- Next meeting: December 1; November reserved for planning. Board of Regents (Nov 12–13) expected to have no major items; Jose may present an academic update.
- Jose's department visits highlight UNI's uniqueness and gathers stories/data for stakeholders.
- Jason Chapman, new State Relations Officer and UNI alum, engaging with campus groups.
- Gallagher Bluedorn celebrated 25th anniversary with donor event and Yo-Yo Ma performance.
- UNI volleyball: 46-match MVC win streak, 10-0 season, strong academics. Homecoming events praised for turnout and alumni engagement.

- President's Distinguished Awards saw strong turnout from alumni and community; social media videos showcased alumni and educator impact. Gold and Bold awardee recognized for global work with animals.
- President Nook extended early Thanksgiving wishes and thanked faculty for student success.

### Comments from Provost Herrera

00:08:59 – 00:12:26

- Jose Herrera previewed the November Board of Regents meeting, noting a collaborative report with UNI, Iowa, and Iowa State will be discussed soon.
- Enrollment update: 752 freshman applications from neighboring states (up from 746 last year); total applications slightly ahead of last year (3,576 vs. 3,566). Iowa recruitment still needed.
- Emphasized converting applicants to enrollees and thanked departments for collaboration.
- Closed with holiday greetings and handed off to Deedee for WAR Council update.

00:12:27 – 00:17:35

- Deirdre Heistad outlined WAR Council updates: report presentation scheduled for Nov 13; public release Nov 4.
- Possible Board actions: receive report, direct implementation, or revisit later.
- Shared ROI one-pagers for academic programs using public data and repeatable methods.
- ROI assumptions included loans, but fewer than half of graduates have debt; alternative calculations show faster ROI for low/no debt.
- Addressed broader program vitality metrics (teaching load, faculty count, mission centrality) as outside current study but acknowledged their importance.
- Encouraged watching the livestream of the Board meeting.

00:17:44 – 00:22:19

- Alexa Clements invited questions on WAR Council report.
- Karen Breitbach asked if challenges were shared by Iowa and Iowa State; Heistad confirmed uniform metrics across Regent's institutions.
- Clements raised concerns about ROI one-pager accuracy; Heistad explained there had been revisions with deans and focus on graduate outcomes.
- Heistad noted data may not reflect departmental contributions like general education or accreditation.
- Clements thanked Heistad and emphasized the importance of this context for departmental discussions.

### Comments from Faculty Chair Elgersma

00:22:22 – 00:24:01

- Chair Elgersma announced that open enrollment will begin in the coming days and encouraged senators to share this information with their departments. He emphasized that this year's changes include new coverage tiers, which may affect prescription costs and other benefits, making it especially important for faculty and staff to review their options carefully.

- He also noted that Human Resources is still working to verify dependent information for a few employees. Faculty and staff unsure of their status are encouraged to contact HR directly for clarification, which can be done easily via email.

### **Comments from United Faculty President Martin**

00:24:11 – 00:25:29

- Christopher Martin shared that UNI, in collaboration with Iowa and Iowa State through the Iowa Higher Ed Coalition, issued a joint statement on October 15 rejecting the proposal to join the federal Compact for Academic Excellence in Higher Education.
- One of the primary concerns was the compact's call for a five-year tuition freeze, which the coalition argued would be financially harmful to UNI and the other institutions. Supporting materials, including graphics and data, were included to illustrate the impact.
- Martin noted that research shows tuition freezes can disproportionately affect low-resource students, ultimately increasing costs for them and their families. He encouraged attendees to review the statement, available at [ufaculty.uni.edu](http://ufaculty.uni.edu), and expressed appreciation for the collaboration with faculty at Iowa and Iowa State.

### **Comments from NISG President Webster**

00:25:41 – 00:26:13

- Alli Webster shared that she and her vice president, Gabe, are preparing to attend the upcoming Board of Regents meeting in November. She noted that their current focus includes monitoring developments related to the Iowa Higher Ed Coalition and the suggestions mentioned earlier by President Martin.
- Webster did not have additional updates but welcomed any questions from attendees.

### **Comments from Senate Chair Clements**

00:26:22 – 00:30:29

- Senate Chair Clements shared info on HR Benefits October newsletter link for guidance on open enrollment, tiered plans, prescriptions, and flex benefits; additional resources on HR website.
- A colleague of Alexa's predicts a snowier winter due to weak El Niño; faculty advised to plan January courses accordingly.
- President Nook noted winter weather is the only reason UNI has canceled classes since COVID; campus remains open. Closure decisions made by provost and VP for finance/operations.
- Senator Barbara Cutter asked about next year's insurance premiums; Alexa and Kenneth Elgersma suggested contacting HR and confirmed premiums were likely reported at last Board meeting.

- Senator Moore moved to approve; Senator Kogl seconded.
- Discussion included:
  - Correction of Charlie Kirk's name (was incorrectly spelled as "Cook").
  - Correction of NASG President Alli Webster's name (remove "e" at the end).
  - Update number of senators in attendance from 25 to 26.
- Vice Chair Dooley confirmed the attendance correction.
- Motion voted on and passed (25 yes, 0 no, 0 abstain).

- Alexa introduced Julianne Gassman, Chair of the Service and Giving Committee, for an update on UNI Day of Service.
- Julianne highlighted **Spring Into Service: Cats Who Care**, continuing sesquicentennial celebrations with a focus on service and giving throughout spring semester.
- UNI Day of Service scheduled for **April 8, 2026**; campus invited to participate in community-focused projects.
- Faculty options for April 8:
  - Hold class as usual.
  - Require student participation in service activities curated by the committee.
  - Embed service projects into coursework or department-wide initiatives.
- Committee is collecting volunteer opportunities, ranging from hands-on activities to ideation sessions with nonprofits.
- Encouraged early planning for faculty teaching on April 8; flexibility needed for students balancing multiple commitments.
- Resources available on the website for integrating service into courses, including reflection activities.
- Emphasized collaboration and creativity to ensure meaningful, mutually beneficial experiences.
- Julianne shared an example project: delivering **150 beds** to families in need for UNI's 150th anniversary, coordinated by Love, Inc.
- Department heads asked to complete a survey on class plans for April 8 (hold class, require service, or embed projects) to help plan volunteer opportunities.
- Vice Chair Dooley asked about volunteer listings; Julianne confirmed opportunities will be shared before semester ends, with registration opening in January.
- Priority deadline for submitting volunteer projects: **Nov 13**; funding applications open **Dec 1**.

- Shelley Price-Williams asked about project locations; Julianne said primarily Cedar Valley but open to surrounding communities and virtual options. Transportation funding and vehicles reserved for off-campus projects.
- Julianne emphasized flexibility for students balancing multiple commitments and encouraged faculty to plan early.
- Alexa thanked Julianne and noted updates can be shared with Senate as planning progresses.

1662 [CONSULTATION: Merger of the departments of History and Philosophy & World Religions](#)

00:48:48 – 01:00:26

- Chair Clements welcomed Brenda Bass, Jennifer McNabb, John Burnight, and Mary Black for an update on the proposed merger of History and Philosophy & World Religions (PWR).
- Brenda Bass explained the initiative began with department heads exploring synergies and efficiencies; both deans expressed support.
- Jennifer McNabb shared background:
  - Discussions with interim PWR head Mike Graziano since May.
  - Faculty retreats held; both departments voted to proceed.
  - Plan: PWR programs join History in CSBS; steering committee formed to review programs and explore shared opportunities.
- John Burnight emphasized strong faculty enthusiasm and potential for interdisciplinary collaboration.
- Mary Black noted the merger is faculty-driven, focused on academic alignment rather than cost savings, with anticipated benefits for both programs.
- Senator Cutter affirmed faculty enthusiasm for the merger, emphasizing collaboration and synergies over efficiency.
- Chair Elgersma asked about staff involvement; Jennifer McNabb noted PWR's administrator is retiring, minimizing impact.
- Jennifer clarified merger discussions predated the WAR review and stemmed from civic literacy and interdisciplinary initiatives.
- Steering committee will address faculty evaluation concerns; initial plan is to maintain separate department papers during transition.
- Goal: ensure transparency and avoid sudden changes for faculty pursuing promotion.
- Senator Cutter stressed the process will remain open and democratic, with no pressure on programs.
- Alexa reiterated importance of faculty involvement in evaluation and promotion discussions.

- Heistad clarified BS change was editorial and approved by dean, not UCC.
- Alexa praised cover letter organization; Heistad credited Cheryl Nedrow.
- Motion voted on and passed: **24 yes, 0 no, 0 abstain.**
